### **Which layout to use?**

The original layout of EPR Toolbox materials can only be used if the content has not been adapted at all.

If the EPR Toolbox is translated but the original content is not adapted, the original design and PREVENT branding must be maintained as well. Further logos and a reference in the imprint, stating who provided the translation, can be added.

If content of the EPR Toolbox is amended or extracted for other formats, the layout of the acting organisation shall be used. Example:

### **Extracting content**

If you create new material and the content is based on the PREVENT EPR Toolbox, the PREVENT Waste Alliance must always be mentioned as the source. This also applies when extracting figures, graphs and tables. Different ways are possible, e.g.:

Source: Cite the name, the year of creation, if possible, the exact document from which you took the information and ideally the link to the website. Example:

*PREVENT Waste Alliance. 2020. EPR Toolbox. Factsheet 02: How can a PRO be established?. More information: <https://prevent-waste.net/en/epr-toolbox/>.*
